# IISc's Knowledge and E-Learning Network (I-KEN) Centre for Continuing Education (CCE), Indian Institute of Science (IISc) Expression of Interest for M.Tech. (Online) Programme

Greetings from IISc's Knowledge and E-Learning Network!

In keeping with changing needs of the industry, advancement of technology and combining the National Education Policy (NEP 2020), the Indian Institute of Science, Bengaluru, has launched the Master of Technology (Online) degree programme. This is a fully online programme, for working engineers and scientists having a BE/BTech/equivalent degree. A Company can sponsor their employees to this programme and enable them to be future ready by upskilling or re-skilling. The programme has over 300 students from 25+ companies currently enrolled across 3 batches, and over 70 of them have completed their graduation requirements.

The following streams are offered for admission in the academic year 2023-24:

- Data Science and Business Analytics
- Artificial Intelligence
- Electronics and Communication Engineering

We anticipate that the Online degree programme will extend to other areas in the next few years. This programme is available only to employees of organisations that have entered into a Memorandum of Agreement (MoA) with IISc. The professionals must be employed full time with the organisation while pursuing this programme. Classes and content will all be delivered online. Assessment will be based on online examinations. The nominal duration to complete the degree programme is between two and three years.

The degree awarded is on par with the M.Tech degrees offered by IISc.

The Admissions process in each academic year under the MoA is as follows:

- The sponsoring organisation will recommend a list of their employees who meet the minimum eligibility criteria as candidates to one or more streams;
- A written and/or an online interview will be conducted for these candidates by IISc to evaluate their suitability and we will prepare a merit list;
- The organizations will confirm the merit list and approve the employees for enrolment in a stream.

The fee for the programme depends on the stream of enrolment and ranges between Rs. 8.8 lakhs - 10.0 lakhs for the entire programme. The fee is **paid progressively each semester** based on the course and project credits taken by the students.

#### Are you Interested?

Organizations interested in participating in this programme and executing an MoA with IISc are requested to provide their **Expression of Interest (EoI)** in the form given below. The EoI must be initiated from the Head of Human Resources or Learning & Development or an equivalent authority on the company's letterhead. The form may be filled, and a signed and scanned or an e-signed document may be sent to <a href="mailto:office.iken@iisc.ac.in">office.iken@iisc.ac.in</a>. Expressions of Interest may be submitted any time.

Companies meeting the following criteria are eligible to send the Eol:

- Companies with an established track record (five years and more) in technology, research, and development in the indicated three streams
- Government research and development organisations and public sector units

#### **Next Steps**

- A committee at IISc will examine the submitted Expressions of Interest and will shortlist organisations for further discussions.
- The decision of the committee on the shortlist will be binding. Organisations that are not shortlisted can submit a new expression of interest in future academic years.
- The Institute and the shortlisted companies will enter into a Memorandum of Agreement (MoA) for the programme. A draft of the MoA will be shared after shortlisting the organisation.
- Companies who already have an MoA under this specific programme with IISc do not need to resubmit the Expression of Interest. The list of companies having an MoA are given in the I-KEN website.
